APPC Proposal: Education Name Change

Effective fall 2019 the degree field Early Childhood Education (P-5) is referred to as Elementary Education Degree (P-5). This was a ruling by GaPSC. All USG colleges have followed suit. We changed ours in a APPC meeting this past fall 2019 but we did not formally inform the USG. Please see the below ruling by the commission. We need a formal vote and process that will involve a submission of change to the USG.

Additionally, if approved this may change the CIP Code. This program name change better represents the program since Early Childhood Education refers typically to grades K-3rd and Elementary Education refers to grades K-8th, which better reflects of our program (K-5th).

On May 9, 2019, the Commission repealed/amended/adopted the aforementioned rules, effective July 1, 2019.
