The East Georgia State College Foundation Board of Trustees met for the Annual Meeting on April 24, 2018.

Attending were: Dr. Bob Boehmer, Denny Key, Harriet Ray, Donald Jenkins, Dustin Durden, Steven Rigdon, Matt Donaldson, Bobby Reeves. Denny Key welcomed the group, gave the invocation and called the meeting to order.

Harriet Ray presented the minutes from the November, 2017 meeting. They were approved unanimously.

Cliff Gay presented the financial statements. They were approved unanimously.

President's Comments - Dr. Boehmer spoke in regard to three topics:

- 1. Graduation is May 4. Denny Key will be our speaker. We have 164 graduates, 144 participating in graduation exercises. We have 6 dually enrolled students that will graduate from EGSC prior to their high school graduation a couple of weeks later.
- 2. Our budget allocation increased about \$800,000. Dr. Boehmer explained how this was good but after all the expenses we have to cover, it will really not be a substantial increase.
- 3. Our next capital project is underway. The student center expansion groundbreaking is set for August 16.

#### The Real Estate/Finance committee

- 1. Recommended to the Executive committee --- the money in the Royal Alliance Fund to be transferred to the unrestricted balance in the foundation accounts.
- 2. Recommended we continue to work on the approved plan for selling personal property at the Morgan House.
- 3. Announced a meeting would be set with the Gambrell family to discuss the gift of the acreage.

#### The Membership Committee

The committee recommends the following to the Executive committee for presentation to the full board:

- 1. Accept the resignation of Trustee Scott Rosenau due to a job relocation to Ohio.
- 2. Recommend the following slate of officers for fiscal year 2018-19:

- 4. Recommend a by-law change to add an Alumni committee to assist with advising and directing the alumni programs at EGSC.
- 5. Recommend the following committee assignments (note Executive board is a part of each committee)

#### The Executive Committee

- 1. Recommend to the full board to accept the finance committee's recommendation to move the Royal Alliance funds to the unrestricted balance in the foundation. (approximately \$21,000.)
- 2. Recommend to the full board to accept the following giving level designations to be publicized:
- a. Cumulative giving of \$100,000 or more President's Club
- b. Cumulative giving of \$50,000 \$99,999 1973 Society
- c. Cumulative giving of \$25,000 \$49,999 Heritage Circle
- d. Cumulative giving of \$5,000 \$24,999 Patrons
- e. Cumulative giving of \$1 \$4,999 Friends of EGSC
- 3. Recommend the ratification of the available scholarship funds listed on attachment
- 4. Recommend that the Morgan House be made available for rental for events
- 5. Recommend the proposals of the Membership Committee

- Elizabeth announced that we have received a grant for the Vision Series from the Cleon Mauldin Foundation.
