The EGSC Foundation Budget, Finance, Investment and Real Estate committee met at noon Tuesday, February 25, 2020 in the President's conference room. Attending were Chairman Milton Gray, Guy Singletary, Richard McNeely, Denny Key, Dustin Durden, Cliff Gay, Wade Johnson, Bobby Sasser and President Boehmer. Special guest was Greg Stewart

Chairman Gray welcomed everyone and introduced Mr. Stewart, a contractor who had inspected the Morgan House for the purpose of determining the cost of what needed to be done. The report was positive. Mr. Stewart feels that the repairs will not be as costly as first thought. The discussion included the need for cleaning the pool house roof to determine the shape the roof is in, replacing flashing on the house, replacing rotten boards, repair to the sleeping porch and shoring up the retaining wall. A scope of work should also be prepared to include 3 alternatives, inside the house, outside of the house and outside and the downstairs of the house. Chairman Gray will report on this to the full board.

Other business included

- Review of the insurance claim for the damage to the house from the 12/24/19 storm. It has all been repaired.
- The allocation of scholarships was recommended as presented to go to the executive committee for approval and vote at the full board meeting.
