

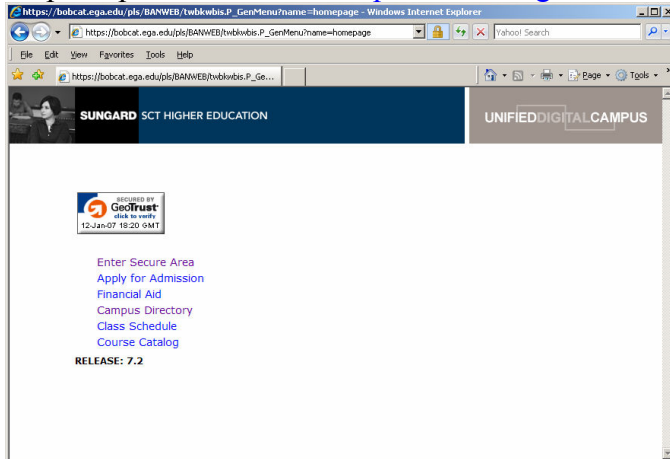
Student 1098 Supplement Data

This data can be obtained via Banner Web.

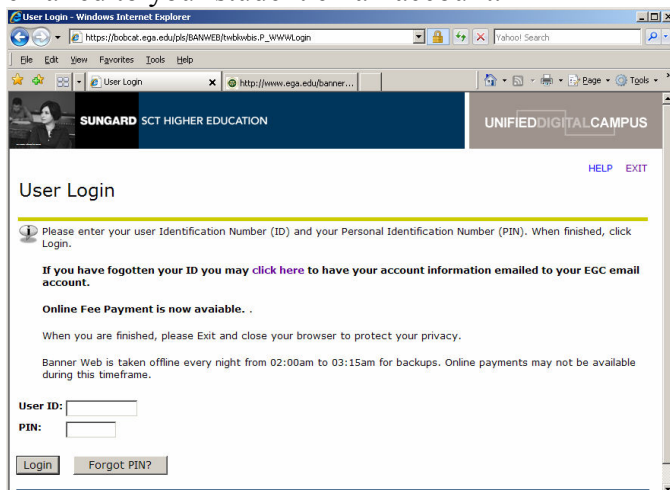
To view this data, follow the steps below:

Step1: Open a browser to <https://bobcat.ega.edu>

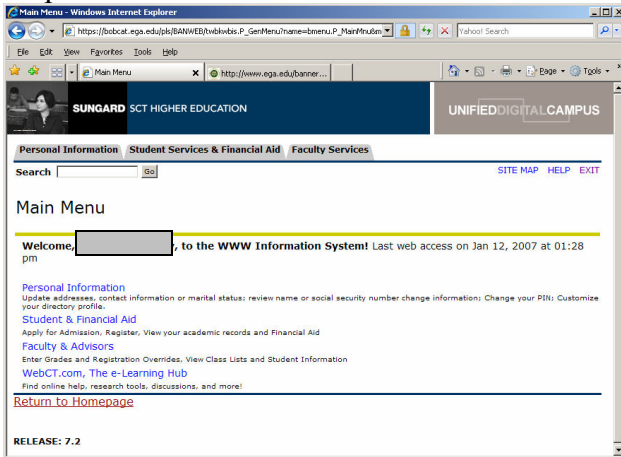


Step 2: Click Enter Secure Area and enter your account information.

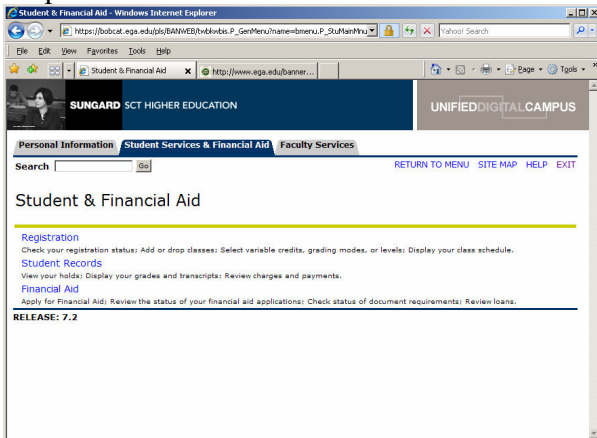

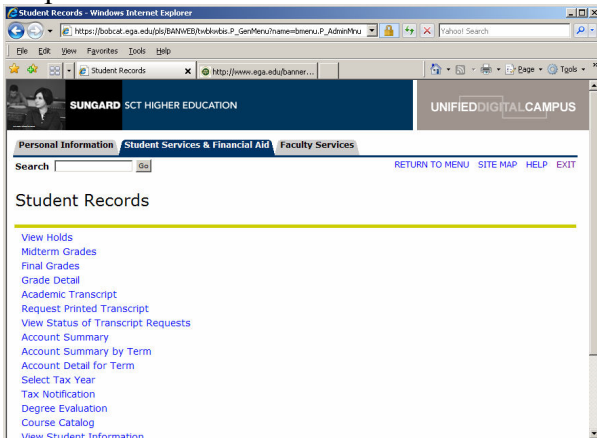
Step 3. Select the “Student & Financial Aid” menu



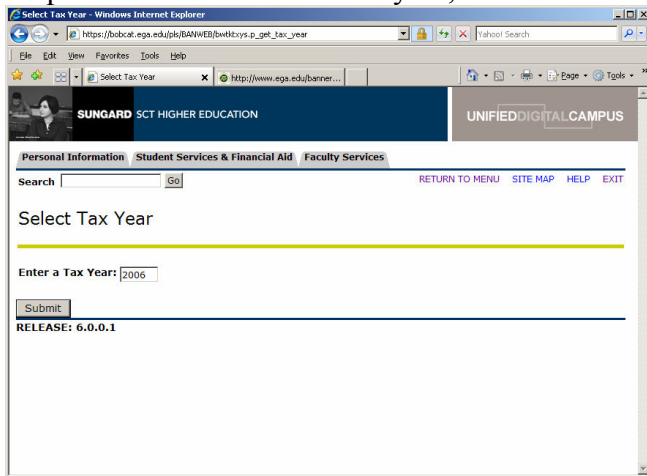
Step 4. Select the “Student Records” menu
