The committee discussed the Distance Education and eLearning Committee course that has been created in D2L. All committee members have been enrolled into the course. This course has the EGSC template and module structure. Sandboxes have been created for Dr. Upchurch and Ms. Jordan with the template in the courses. Sandboxes are available upon request.

The course evaluation process was discussed. Faculty will be notified in advance of the evaluation process and the ION rubric will be provided with the notification. Faculty will complete a self-review of their course/courses and return the completed ION rubric to the Director of eLearning and the review team. The completed rubrics will be stored in the eLearning department. A copy of the completed rubrics will be submitted to the appropriate Dean.

There were questions and discussions about the review team and if courses would be reviewed by one committee member or two committee members. If two members complete a course review, both rubrics will be sent to the dean.

The committee also discussed the timing of the reviews and after searching for more information about the previous course evaluations I found the schedule that Dee had used. I have added Dee's schedule below and my proposed evaluation cycle below it. Since the evaluations were not completed in Fall of 2019/Spring 2020, I would like to propose a change to the cycle and begin with the Fall 2020 courses. The evaluations for Fall 2020 courses would be completed by May 2021 and Spring 2021 courses would need to be completed by June 2021.

This schedule provides the information about the timing of the evaluations and when they are due.
