Admissions Package for Home Educated Applicants

The following items are necessary to compile an admissions package for Home Educated applicants to East Georgia State College.

- \$20 Application for Admission/Non-refundable application processing fee
- Official SAT or ACT scores** sent to EGSC directly from the testing agency: (SATV 430 and SATM 420) or (ACT English 17 and ACT Math 17)
- Official transcripts from any conventional public/private high school and colleges attended with a 2.0 academic grade point average in Required High School Curriculum
- Completed Home School Required High School Curriculum Credit Evaluation Form (see page 3 of this handout) and Supplemental Documentation.
- Affidavit from primary teacher and student certifying completion of high school and date of high school graduation, and a copy of your diploma if you have already graduated.

**Home school applicants who receive a General Education Development (GED) Diploma will need to submit official passing GED scores as well as a Home School Portfolio for Required High School Curriculum Evaluation. SAT/ACT scores are not required for applicants with GED.

*Entrance Exam (COMPASS) will be required prior to registration for students who do not have exempting scores.

Your completed application and portfolio packet should be submitted to the East Georgia State College Office of Admissions prior to the deadline for the term of which you are applying.
