These additions pertain to the Legislative Mandate additions to all our POLS 1101 courses as approved by the state's RAC POLS Subcommittee with the emphasis that the course includes the teaching of the U.S. and Georgia constitutions. These outcomes were also voted on by the EGSC Faculty and passed by a majority. If approved, these SLO's will be adopted by EGSC (all institutions in the state are engaging in this same process) and these additional SLO's will connect into every instructor's syllabus that teach the POLS 1101 course.
